

# **VA/DoD Survivor Forum Update**

Casualty, Mortuary Affairs, and Military Funeral Honors Military Community and Family Policy (MC&FP).

On May 12,2022, Ms Deborah S. Skillman presented at the VA DOD quarterly virtual forum. Ms Skillman is the Director Casualty, Mortuary Affairs, and Military Funeral Honors Military Community and Family Policy (MC&FP). According to Ms Skillman's presentation "The mission of the Casualty, Mortuary Affairs, and Military Funeral Honors program is to provide oversight of DoD and Service policies pertaining to casualty, mortuary, and military funeral honors programs and to provide authorized and necessary assistance to eligible family members of deceased, missing, ill, or injured personnel. Assistance may include but is not limited to transportation assistance; applying for and receiving benefits and entitlements; obtaining copies of records, reports, and investigations; legal assistance; receipt of personal effects; mortuary, burial, and funeral honors assistance; relocation assistance, including shipment of household goods; liaison with other federal agencies; information and referral, including emotional and spiritual support, and other assistance as requested." (VA DOD Forum May 2022)

Ms Skillman provided updates regarding current DoD programs as well as what programs are looming on the horizon pertaining to military survivors.

# State Highlights-Virginia

## **State of Virginia Success Story!**





Virginia: MOAA's Surviving Spouse Edith Smith (pictured above in blue) was instrumental in the change in State Benefits for military surviving spouses. Edith Smith, MOAA Surviving Spouse Member, and a handful of military survivors advocated to the elected official to allow for survivors of service members 100% disabled to receive exemption for property tax. A bill to provide each of 135 government localities the ability to pass an ordinance for the tax exemption by their own standards. This year will be a constitutional amendment to provide an active duty/line of duty surviving spouse to provide an equal tax exemption statewide across all localities as none seem to be doing it this year. Results of recent legislative efforts: Passed! The MOAA Council of Chapters Virginia met yesterday and adopted this as a legislative goal to obtain a Constitutional Amendment. It will need to be passed two years in a row with an election between.

# **North Carolina**

### **Property Tax Exemption:**

A recent bill has been introduced to the NC state legislation to allow for the 100% disabled and surviving spouses to be exempted from State Property tax. Currently there is a \$45,000 reduction of Survivors assessed property to allow for a lower tax rate. Military surviving spouses who receive Dependency Indemnity Compensation (DIC) from the VA are eligible for up to a \$45,000 deduction in the assessed value of their home for property tax purposes. \$45,000 is the maximum allowed exclusion for property tax relief N.C.G.A 105.277.1C. This is an antiquated law that is not applicable or adequate enough to the inflated current property assessments.

Example: If your home value is assessed at \$300,000, you pay taxes according to the assessment. This benefit would subtract \$45,000, from your predetermined property value assessment. If you meet the criteria your yearly property tax assessment is now calculated at the value of \$255,000. Today the median listing price for a home is Asheville NC is \$502,900.00 (www/realtor.com)

### **MOAA's Legislative Surviving Spouse Corner**

MOAA surviving spouses are members of this outstanding organization. We do have a voice. It is pertinent to understand our benefits, the good, bad, and the ugly. Understanding legislation can be made easy if explained in layman's terms. Hopefully this section with facilitate knowledge and allow for a certain comfort level that would promote advocacy for change. Persistent grassroots will keep our issues alive!

#### Here are some pertinent legislative efforts MOAA is promoting:

<u>Caring for Survivors Act</u> Raises the VA Dependency and Indemnity Compensation (DIC) aligning to the same levels as other federal survivor programs. This legislation would increase VA DIC benefit from 43% to 55% of the compensation of a 100% disabled veteran. Currently DIC is \$1,437.66.

- Bill numbers: H.R. 3402 | S. 976
- Legislative Action Center link: Act Now to Improve Survivors' Benefits

This important legislation would raise Dependency and Indemnity Compensation (DIC) to the same levels as other federal survivor programs. It would boost DIC to 55% of the compensation of a 100% disabled veteran, up from the current 43%; correcting this injustice is long overdue. It is very costly, 20 billon over ten years (unofficial score), and will take time to find the necessary funding. This means we need to keep the bill "alive" until funding is possible. Surviving spouses need to be involved in long-term advocacy to help build co-sponsors in both the House and the Senate.

This bill is supported by many other Veteran Services Organizations (VSO). Collectively, VSO's agreed to support this effort only if the language of this bill would also include changing the "10-year rule." What is the Ten Year Rule? This policy prohibits survivors from receiving DIC benefits if a 100% disabled servicemember dies of a non-service-connected injury less than 10 years after receiving that disability rating. This bill would change the 10 year rule to a five year rule. The surviving spouse would be eligible to receive a portion of the DIC beginning at the five year mark. The amount of DIC would increase until hitting the ten-year mark. At that time the surviving spouse would receive the full DIC.

#### Military Retiree Survivor Comfort Act

According to MOAA Legislation: When a retired servicemember passes, the Defense Finance and Accounting Service (DFAS) recoups their last month of retirement pay. This is frequently a terrible surprise for a new survivor and adds unnecessary financial stress to a grieving widow. The Military Retiree Survivor Comfort Act would allow survivors to avoid this immediate recoupment (and prevent surprise overdraft fees) and instead gradually repay the amount over the next 12 months or request debt forgiveness (MOAA ,2022).
