On top of that he was always so considerate and loving with family and friends. Mike never missed sending Valentines and birthday wishes to family including his sistersin-law. His Border Collies will miss Mike's kindness and love of nature as they remember their long walks and herding sheep. Mike even found time to become a Master Gardener in Hendersonville.

Mike and Joanie have been in love like two peas in a pod for almost 50 years. They have been blessed to travel the country and the world with family and friends across Europe, Asia, North and South America, the Caribbean, the Middle East and Africa.



THE 4TH OF JULY IS COMING



WASHINGTON – Federal law authorizes veterans to salute the flag in the following situations:

The Pledge of Allegiance. Members of the Armed Forces not in uniform and veterans may render the military salute in the manner provided for persons in uniform. Alternately, military personnel and veterans not in uniform may stand at attention facing the flag with the right hand over the

heart. When not in uniform men should remove any nonreligious headdress with their right hand and hold it at the left shoulder, the hand being over the heart (Title 4 USC section 4).

During hoisting, lowering or passing of the American flag. Members of the Armed Forces and veterans who are present but not in uniform may render the military salute. All such conduct toward the flag in a moving column should be rendered at the moment the flag passes. (Title 4 USC section 9).

National Anthem. Members of the Armed Forces and veterans who are present but not in uniform may render the military salute in the manner provided for individuals in uniform. When the flag is not displayed, all present should face toward the music and act in the same manner they would if the flag were displayed. (Title 36 USC section 301).

MOAA GUIDANCE ON PARTISAN POLITICAL ACTIVITIES

Partisan Political Activities. As organizations exempt from federal taxation under Sec. 501(c)(19) of the Internal Revenue Code, MOAA and its affiliates must take care to avoid engaging in partisan political activities. Under IRS rules, we are prohibited from directly or indirectly participating in, or intervening in, any political campaign on behalf of (or in opposition to) any candidate for public office.

Candidates for Public Office. A candidate for public office is an individual who offers himself or herself, or is proposed by others, as a contestant for an elective public office, whether such office is national, state, or local, and includes incumbent candidates. The prohibition also extends beyond declared candidates and may apply to efforts to recruit an individual to run for office or advance exploratory activities. The prohibition also applies to advocating for the platform of one political party over another.

Prohibited Activities. Activities which constitute participation or intervention in a political campaign on behalf of or in opposition to a candidate include, but are not limited to, the publication or distribution of written or printed statements or the making of oral statements on behalf of or in opposition to such a candidate. It is clear that the prohibition on partisan political activity prohibits such outright actions such as posting a "Vote for Biden" or "Vote for Trump" on the organization's website, or "Support Republican Candidates" or "Vote Democratic."

In addition to these obvious examples, the prohibition goes well beyond direct expressions of support. In determining whether an organization is engaged in unlawful partisan political activities, the IRS applies a "facts and circumstances" test. The IRS looks not only to the expressed language, but to external factors, such as the communication's timing, its targeted audience, and how the message relates to public policy positions that distinguish a candidate in a campaign.

Consequences for Violations. The consequences to an organization that violates the prohibition on partisan political activity can be severe including the loss of its tax exempt status and the imposition of certain excise taxes. For public charities, like The MOAA Foundation and the MOAA Scholarship Fund, the IRS can disallow tax deductions for charitable contributions. In addition, for an organization whose mission involves advocacy on key military community issues, MOAA must seek support from elected representatives from both parties. Engaging in partisan political activities on behalf of one party or candidate would seriously undermine MOAA's ability to achieve the bipartisan consensus on key issues essential to achieving its legislative objectives.

Personal Opinions. As individuals, members and leaders of MOAA and MOAA's affiliates are not prohibited from engaging in partisan political activities so long as they do so in way that makes it clear they are acting for themselves and do not appear to be speaking on behalf of MOAA or its affiliates. For example, it is permissible for an individual to express his or her personal preference in support of or in opposition to a candidate or political party. And they may do so publicly. However, when expressing their personal opinions or preferences, they may not make reference to their MOAA position, use MOAA communications channels, use MOAA letterhead or newsletters, identify themselves as MOAA leaders, or imply that MOAA or its members share their beliefs.

Leadership Responsibilities. Those in leadership positions have a special responsibility to separate their personal political opinions from statements that are or can be attributed to MOAA or its affiliates. For example, it is improper for a chapter leader to use the chapter's newsletter to advance the leader's personal political beliefs. This goes beyond statements expressly advocating for a specific candidate or party by name. Statements that incorporate campaign messaging, campaign slogans, and political positions identified with a particular candidate or party are also prohibited. No MOAA leader is authorized to use MOAA's or an affiliate's resources to communicate their personal political beliefs. This is an outright violation of the leader's fiduciary duty to the organization and a serious leadership and ethical failure.

Divisive Social Issues. We are all aware of the divisive nature of the debate over today's leading social issues – protesting during the national anthem at sporting events, racial justice, public protests, and the conduct of law enforcement officers. These are issues over which many Americans have deeply held, but differing, personal beliefs. This is also true within the military community among the ranks of active duty and retired officers and within MOAA itself. MOAA leaders have an obligation to keep this in mind when communicating on behalf of MOAA or its affiliates. Suggesting that MOAA only supports one side of a deeply divisive issue sends a message to those with a different belief that MOAA is not for them. Officers today have grown up in a military culture that is very different than the past. Many are accepting of attitudes and views that were not mainstream when many of us were in uniform. If MOAA is going to connect with the newest generation of uniformed officers, it needs to be clear that those with strong views on racial and social justice imperatives are just as welcome as those who adhere to more traditional expressions of patriotism and officership.

MEMBER SPOTLIGHT
Col. Jeri Graham, USA (Ret)

Army Nurse Honored for Her Service



Member served as chief nurse at Walter Reed.

hough Col. Jeri Graham, USA (Ret), was 35 years old when she joined the Army, she said her path to military service perhaps began when she was born. Her father served in the Army in World War II. He was injured and received a Purple Heart.

"I always knew he was saved by the Army medics and doctors," said Graham. "So somewhere, it was in my heart that I had some payback because had he not been saved, I would not have been born."

Graham went on to serve 24 years in the Army Nurse Corps, and they were filled with accomplishments and honors.

Most recently, she was among 13 women servicemembers including two fellow MOAA members — inducted into the Army Women's Foundation Hall of Fame during a ceremony March 22 at Fort Belvoir, Va. Women who have served in the Army or the armed forces and contributed extraordinary service are eligible for induction into the hall of fame, which was created in 2009.

Graham, a MOAA board member, was board certified as a nurse-midwife and had a variety of civilian clinical and academic experiences before she was commissioned in the Army Nurse Corps in 1978.

Her first assignment was at Fort Campbell, Ky., as chief of nurse midwifery. While in that role, she decided she needed to find a way to better relate to the young soldiers she was helping to prepare to become fathers.

"I needed to change my understanding that these young soldiers who during the day are trained to be soldiers could just flip their hats around and be loving fathers," she said. "I thought it might be good to wrap my arms around being in the Army."

Graham decided to attend Air Assault School, and she became the first female Army nurse to graduate from it.

"It was a tough course, but I was determined to graduate," she said. "I ended up being one

of only a few who could deliver a baby in a tree," she joked.

Getting her wings, Graham said, "worked like a charm" for dealing with soon-to-be fathers at Fort Campbell.

"It made such a difference to be able to understand their lives and be empathetic to what they do and how to transfer that to supporting their spouses," she said.

During her career as an Army nurse, Graham earned the Air Assault Badge and the Expert Field Medical Badge and had assignments in Germany, at Fitzsimons Army Medical Center in Colorado, as chief nurse at Walter Reed Army Medical Center, and as hospital commander at Fort Leonard Wood, Mo.

While serving at Walter Reed, Graham was diagnosed with cancer, but she never stopped working. She learned from that experience the value of humor in therapy.

"It's what got us, every one of us, through," she said.

• DEATH GRATUITY - A one-time, nontaxable payment to help surviving family members deal with the financial hardships that accompany the loss of a service member.

- SSSB Social Security Survivor Benefits are monthly benefits paid to eligible family members of a deceased service member who has worked and paid Social Security taxes.
- SSIA Special Survivor Indemnity Allowance is a benefit for surviving spouses who receive a Survivor Benefit Plan annuity that is offset by a Dependency and Indemnity Compensation payment from the U.S. Department of Veterans Affairs.
- SGLI Servicemembers' Group Life Insurance is life nsurance coverage for a service member.
- TSGLI Servicemembers' Group Life Insurance Traumatic Injury Protection is financial assistance for service members who incur physical losses due to traumatic injuries.
- FSGLI Family Servicemembers' Group Life Insurance is life insurance coverage for a service member's spouse and dependent children.
- DIC Dependency and Indemnity Compensation is a tax-free monthly payment to survivors provided by the Department of Veterans Affairs.
- SBP The Survivor Benefit Program is a taxable annuity for survivors paid through the Defense Finance and Accounting Service.
- TRICARE The uniformed services' health care program.
- DEA Dependents Educational Assistance is an educational benefit provided by the Department of Veterans Affairs



<u>Urge Your Elected Officials to Support Comprehensive Toxic Exposure Reform Legislation</u>

Comprehensive toxic exposure reform is needed to ensure we avoid the problems faced by Vietnam veterans who were exposed to Agent Orange.

Urge Your Elected Officials to Fix the TRICARE Young Adult Coverage Gap

MOAA continues efforts to build support for The Health Care Fairness for Military Families Act of 2021, H.R. 475 in the House, and S. 1972 in the Senate. These bipartisan and bicameral pieces of legislation would expand TRICARE eligibility to young adult dependents up to age 26, bringing TRICARE in line with commercial plan requirements.

Ask Your Lawmakers to Support the Military Hunger Prevention Act

Food insecurity among junior servicemembers is not a new concern, but like many ongoing problems, it's been made worse by the economic fallout from the COVID-19 pandemic. The Military Hunger Prevention Act would establish a Basic Needs Allowance (BNA) for these servicemembers, helping them overcome financial difficulties and allowing them to concentrate on their duties.

COUNCIL AND CHAPTER AWARDS

MOAA Levels of Excellence Award - Each year, councils and chapters may request to be recognized for one of two <u>Levels of Excellence awards</u>. Councils and chapters that want to be considered for a Levels of Excellence Award need to submit a nomination by May 1.

A standard set of rating criteria will be used to evaluate all councils and chapters that submit a package. Last year, 162 councils and chapters earned 5-star awards. Your council or chapter could be among the winners recognized at a dinner in Kansas City later this year.

Col. Marvin J. Harris Communications Awards - MOAA's annual contest identifying those councils and chapters that do an outstanding job communicating with their members.

Colonel Steve Strobridge Legislative Chair/Liaison Award - This annual award recognizes an affiliate Legislative Chair or Liaison who has demonstrated superior service to their council/chapter and national MOAA in support of national and/or state legislation which affects servicemembers, veterans, retirees, and their families.

2021 Surviving Spouse Liaison Excellence Award- Surviving Spouse Liaisons work at the Council and Chapter level to ensure fellow survivors remain connected to the military family and participate in local and national programs and advocacy efforts.

MOAA ROTC/JROTC Awards Program - MOAA has PDF fillable certificates for ROTC and JROTC available for leaders to add their chapter name and the name of the award recipient.

These programs are entirely voluntary; no MOAA chapter is under any obligation to present a certificate to ROTC and JROTC units. ADVOCACY NATIONAL, STATE, AND LOCAL LEGISLATIVE ISSUES

MOAA - 2022 Advocacy in Action - Major ASKS

MOAA is conducting our annual spring campaign throughout the month of April. Some of our 350,000 members from across the country will soon be reaching out to your legislators to schedule in-person or virtual meetings to discuss this year's campaign topics.

Even if you are not participating in this year's advocacy campaign, we need your help reaching out to your elected officials to let them know about the event, what topics we are advocating for, and what their offices should expect in the coming weeks. MOAA's three advocacy topics this year are:

- The Major Richard Star Act (H.R. 1282/S. 344) would provide concurrent receipt of retired pay and disability pay for combat-injured veterans. This bill already has 205 co-sponsors in the House adding 54 since January and 56 in the Senate. If you already have co-sponsored, I want to thank you and ensure support through floor votes and potential amendments to the FY 2023 NDAA.
- The Stop Copay Overpay Act (H.R. 4824) would overturn the doubling of TRICARE copays for mental health care for uniformed services families and retirees. By co-sponsoring this legislation, you can help remove the costly barrier to mental health care.
- Ensuring a 4.6% military pay raise as a minimum across all ranks would keep faith with members of all eight uniformed services, maintaining the link to the Employment Cost Index (ECI) established by statute. Keeping this full raise intact in the NDAA remains one of MOAA's constant priorities.

We are pleased that a major issue of TOXIC EXPOSURE has been receiving excellent support. The topics above need extra support. Certainly, there are additional legislative concerns but in this annual big campaign, we usually focus on 3 main topics.

Surviving Spouse Corner: 4 Resources for Older Adults

These sometimes-overlooked tools and resources can provide needed support and expertise.

The community of military spouses, encompassing all past and present, is a resilient group of individuals. The ability to change plans in a moment's notice is a skill acquired over years of experience. The other amazing characteristic of military spouses is that we support each other and share tools, benefits, and resources no matter how long we have known each other.

Here are four such items to consider:

<u>VA Aid and Attendance</u>: Also known as housebound allowance, VA Aid and Attendance might be able to provide a monthly financial benefit to assist with personal care services. Financial and physical considerations need to be investigated. Local veteran services organizations are a great place to get neutral information and support.

Geriatric Care Managers: Hiring these professionals can be an unmatched option of support for seniors who do not have family members close. They are social workers for hire that can be on a retained contract or situational contract in case of emergency needs. Their experience can help you navigate insurance coverage, emergency services, or placement recommendations if you are looking into senior living locations.

Board-Certified Elder Law Attorney: Often attorneys will list that they offer estate and/or elder law specialties. This is an important area in that "what you don't know will hurt you." A board-certified elder law attorney has a higher level of training and expertise. Learn more through the <u>National Elder Law Foundation</u>.

Senior Real Estate Specialist (SRES): This designation for Realtors means they have done advanced education for working with homebuyers over age 50. Often, they have a network of additional businesses and services that will assist in making the real estate transaction as smooth as possible. Learn more through the <u>SRES Council</u>. This is a very important benefit for anyone who has lost someone due to COVID. Please help get the word out about this.

Under the law, at a family's request, every eligible veteran will receive military funeral honors, to include the presence of a military funeral honors detail that will oversee folding and presenting the U.S. flag and playing "Taps".
