Complete the form and submit. We anticipate many requests so we ask that you allow at least 60 business days for processing. You will receive an email that confirms your request and lets you know when you can expect an answer. MOAA National will review all requests for appropriate use of funding.

MOAA National forwards the sponsorship request to USAA for final approval. Upon approval, USAA will disburse funds to the council/chapter 5-7 days prior to the actual event. As a reminder, please note that in return for USAA's sponsorship, you accept a commitment to recognize USAA as a sponsor or contributor at the applicable event.
