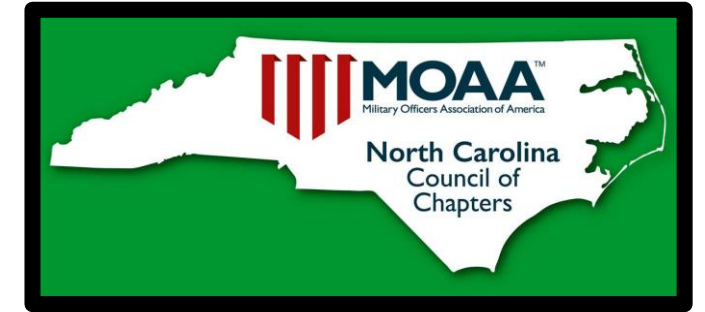

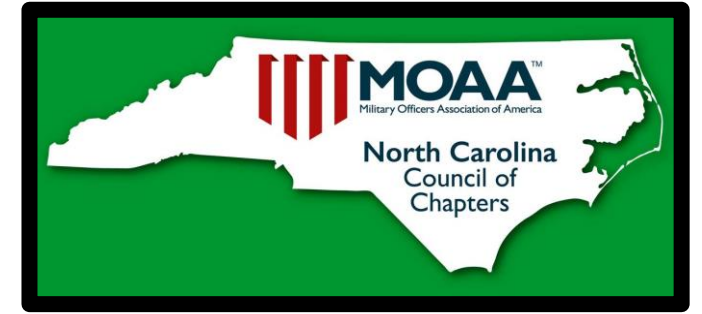
Money Market Investment



- Transferring \$10,000 from BB&T account to “AB Government Money Market Portfolio” (\$5,000) and “Federated Trust for U.S. Treasury Obligations” (\$5,000) money market held by Edward Jones
- Returns less than 1% because of economic decisions by Treasury and Fed.
- No handling fees
- Dividends declared daily, paid monthly
- Same day withdrawal of funds go directly to BB&T account
- Current checking balance ~\$5,000



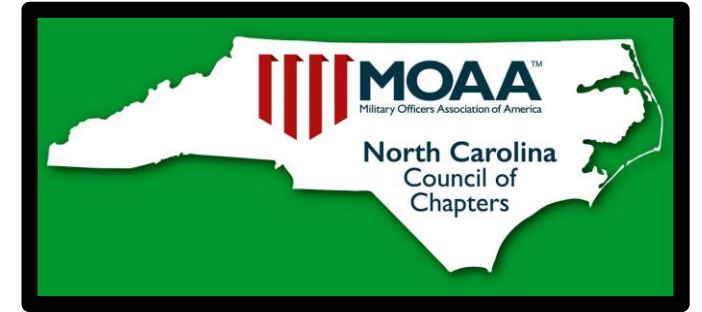
Liability Insurance Status

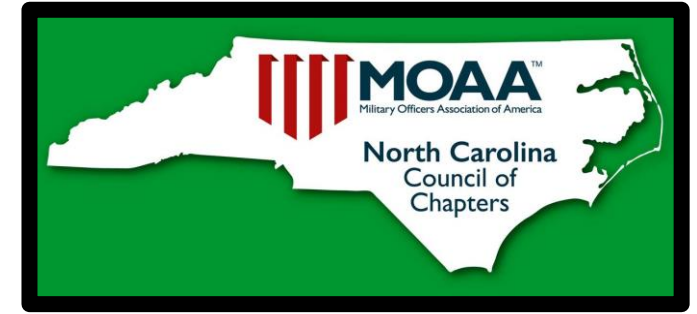

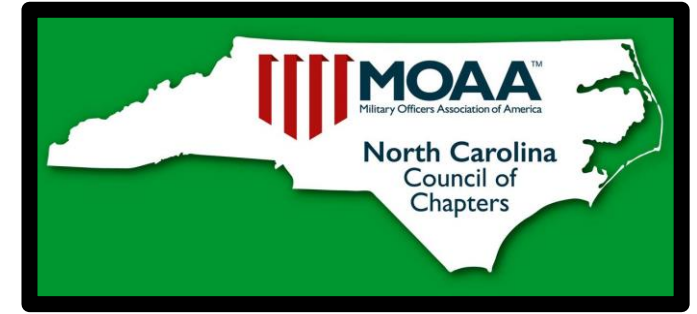

Long-Term Legislative Strategy 2021-2022



- **Purpose:** To obtain relief from NC income tax for active & retired military personnel.
- **Concept:** Organize NC MOAA into 2 elements: Council Team & Chapter Legislative team to begin operations after the Nov. 2020 elections.
 - Council Team: Focus on 2021 & 2022 Legislative Calendar & establish relationship with NC NGA, NC Dept of Military & Veteran Affairs (DMVA) & NC Veterans Council (NCVC)
 - ✓ ID Both Senate/House legislative principals to ensure intro of enacting legislation.
 - ✓ ID both Sen/House appropriate Committee Chairs/Members
 - ✓ Develop point papers for use by Council Team & Chapter Legislative Teams
 - ✓ Attend both Sen/House Committee Meetings
 - ✓ Provide guidance/support to Chapter Legislative Teams.
 - Chapter Legislative Team: Focus on 2021 Legislative Calendar
 - ✓ ID Sen/House legislators in your district following 2020 calendar.
 - ✓ Meet/brief your legislators
 - ✓ Invite your legislators to Chapter meetings.
 - ✓ Meet with local Guard & Reserve, create dialogue & encourage participation
 - ✓ Keep Council Team apprised of your legislative activity



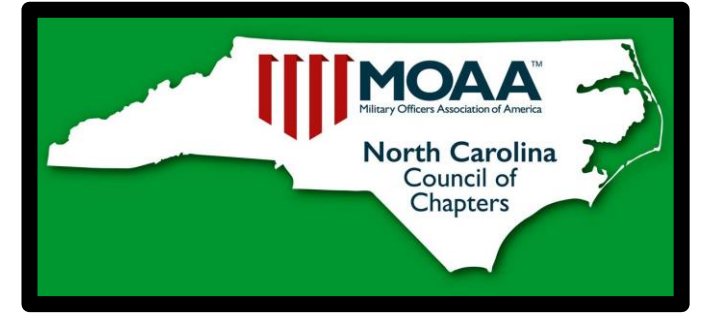

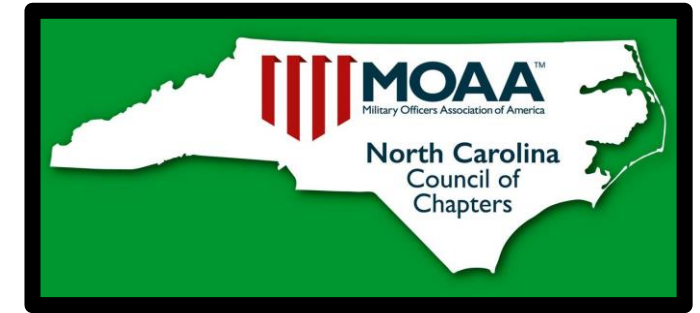

HAVE YOU OR SOMEONE YOU LOVE SERVED IN THE ARMED SERVICES?

Why former Servicemembers and Families should answer "THE QUESTION":

The U.S. Department of Veterans Affairs and the State of North Carolina have benefits and programs that some former Servicemembers and their Families MAY be eligible for. Veterans' Health and Disability Benefits change frequently and differ from conflict to conflict and in peacetime.

Have you or someone you love served in the Active, Reserve, or Guard Services?

Did you experience trauma during your Military Service? (e.g., PTSD, TBI, MST, Moral Injury, Survivor's Guilt)

Are you experiencing health issues connected to your Military Service? (i.e., physical, mental, or behavioral)

Are these issues affecting other aspects of your life? (Employment, Family, and Spiritual Life)

Most Community Providers are NOT prepared to identify or treat Military/Veteran-related Injuries, illnesses, and disabilities.

- Post-Traumatic Stress Disorder (PTSD)
- Military Sexual Trauma (MST)
- Blast Concussions/Traumatic Brain Injury (TBI) Radiation Exposure
- Agent Orange Exposure

- 48%** Felt responsible for the death of an enemy
- 21%** Saved the life of a soldier or civilian

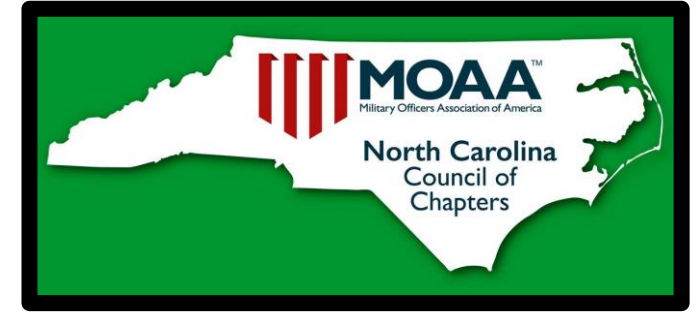

Military Health System Reform

Congress mandated military health system (MHS) reform with the FY2017 National Defense Authorization Act (NDAA)

- TRICARE reforms
- Transition of military treatment facilities (MTFs) to DHA
- Transformation of direct care system → 48 MTFs closed or downsized

National Defense Strategy

Former Secretary of Defense Mattis released the National Defense Strategy in 2018:

- Emphasis on building a more lethal force
- Billets shifted from medical to lethality roles → approximately 18,000 medical billet cuts

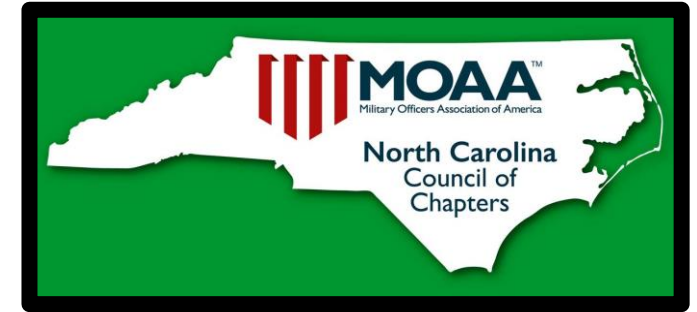

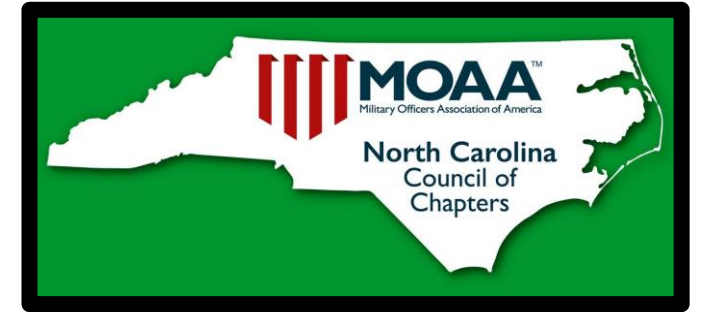

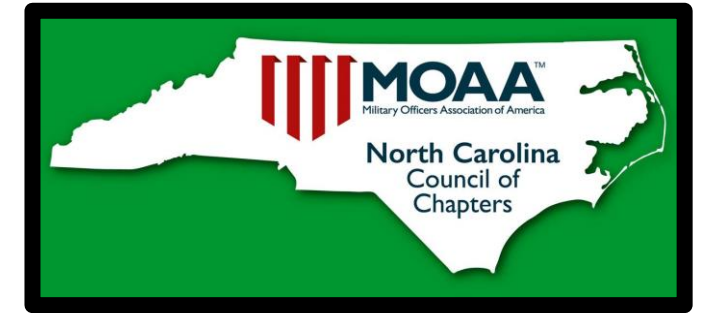
Chapter Recruiting Program

 - Outcomes noted on master spreadsheet -> includes contact information changes.

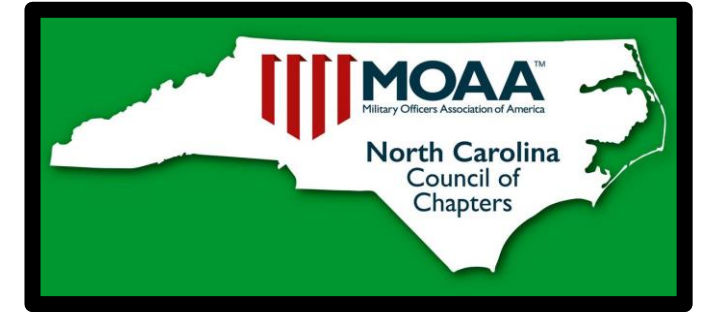
Issues:

- And yet...11 members were on the CM but were not shown as national members?





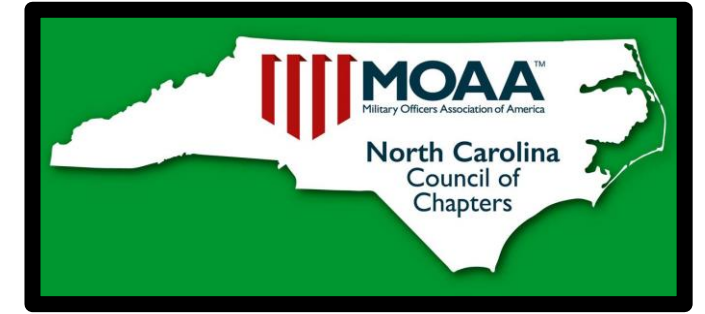
Surviving Spouse Liaison

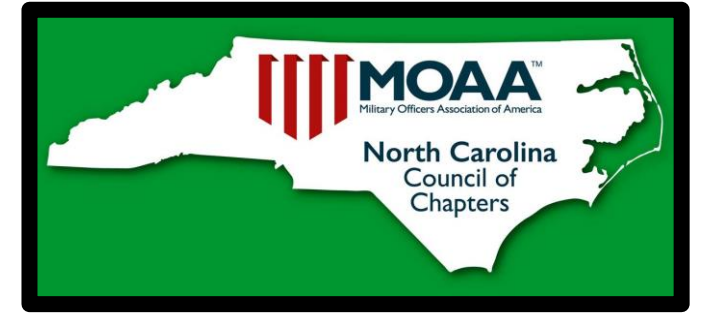

If the Eastern Carolina Chapter should be converted to a satellite, it is proposed that the following counties be realigned to the contiguous chapters to better serve the officers and the communities.

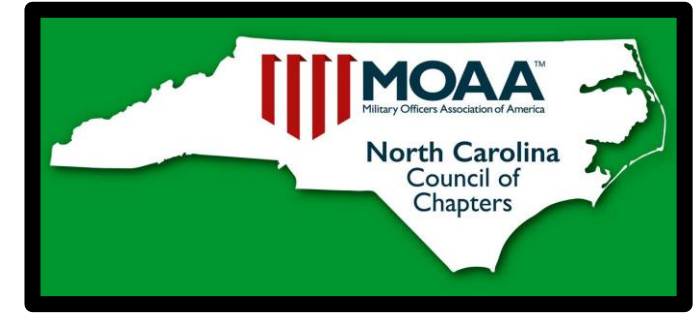
- Duplin County to SENCLand

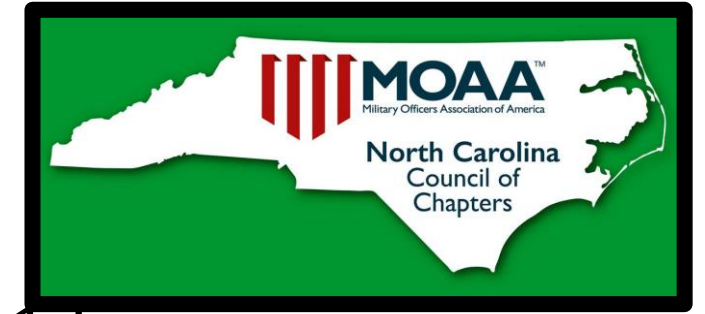

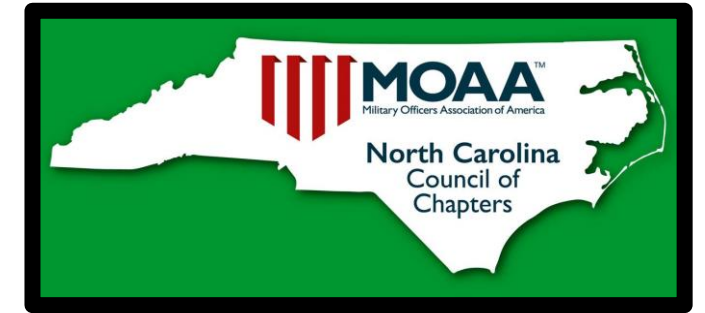

2019 Community Outreach Grants

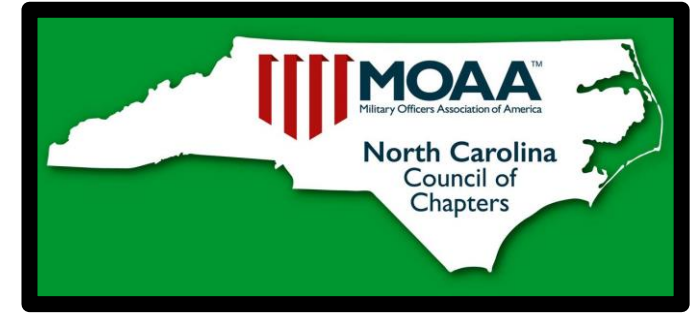


- **Charlotte-Metrolina Chapter** \$5,000.00

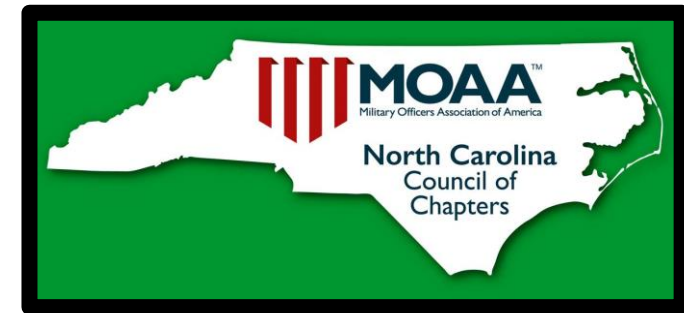


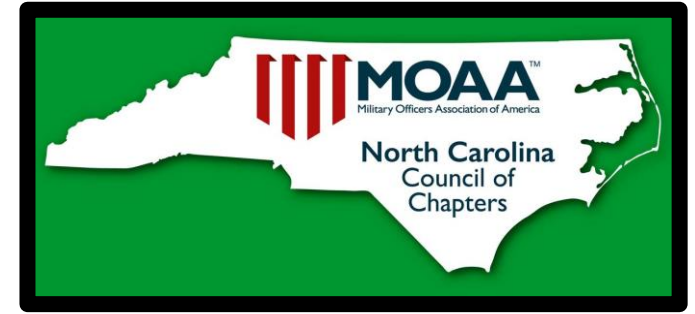
