Comments from three attorneys:

- (1) "An LLC adds protection for the officers. The general liability insurance would kick-in, but the LLC adds additional protection. If D&O is not affordable, LLC adds some protection." Joe Vonnegut, attorney, and serves on the Cape Fear Chapter BOD as a Legal Advisor.
- (2) "Non-profit corporations have essentially the same protection as for-profit corporations from personal liability. However, officers may be sued in certain instances. Therefore, corporation, including non-profits have D&O insurance for directors. D&O is strongly recommended." Dale Hogue, attorney, paleHogue@carolina.rr.com, Charlotte-Metroliona Chapter

(3)"At the NCCOC meeting, you raised the subject of Chapters incorporating as LLCs, in response to guidance from National. You asked those of us with lawyers in our Chapters to get additional information. I dutifully contacted CAPT Dave Lennon, who serves as our legal advisor. He had the following to say"

"Incorporating as an LLC makes a lot of sense. The \$200 per year is very good insurance to protect us from personal liability. The example he used was a suit from someone who contracted Covid19 while involved in a Chapter meeting/activity.

"It is also a good idea for the LLC to have an umbrella policy, since LLCs ordinarily are undercapitalized. They can be abandoned quite easily, whereupon enterprising lawyers will go after individual Chapter members. The example here is of a member driving to a Chapter activity and causing an auto accident with grievous injuries resulting.

"'I also asked about sheltering our scholarship funds from any attempt to sue the LLC. Dave thinks it is a good idea to sequester those funds and other grant funds in a separate 501C3 Foundation.

"Lastly, he strongly discouraged any discussion of whatever coverage each of us carries personally. Lawyers seeking redress for their clients should be directly toward the LLC coverage."
