

## Hershell E. Wolfe (Hew) SES 2/COLONEL, U.S. ARMY, RETIRED

Hershell E. Wolfe (Hew) retired May 2015, with 46 years total Federal Service (Enlisted, Commissioned Officer and Department of Army Civilian). In addition to retirement, he volunteers as a lecturer and consultant at the University of North Carolina Wilmington. He advises the Director of Military Affairs, Computer Sciences and other Colleges. Mr. Wolfe serves as Senior Mentor to the Board of Directors of two small businesses in Norther Virginia (a Native American Company and a female minority firm). Hew serves on the Board of Trustees, Chairs the Men's Fellowship, serves on several committees of the Holden Beach Chapel. Member of the Brunswick Count Veterans Coalition and is the 2<sup>nd</sup> Vice President of the Southeast North Carolina Chapter of the Military Officers Association of America.

**Prior to his retirement Mr. Wolfe was the Deputy Assistant Secretary of the** Army for Environment, Safety and Occupational Health (DASA (ESOH)) from April 10, 2011 to May 2015. Mr. Wolfe provided executive leadership for all Army sustainability, environment, natural resources, safety and occupational health programs including Army National Guard and Reserve activities. He provided leadership, management, and oversight of Army Acquisition **Programs (ESOH issues); Chemical, Biological, Nuclear and Conventional** Treaty Verification and Compliance, the Army Environmental Technology Program, the US/German Technology Data Exchange, the Executive Agent for a number of critical Department of Defense activities, to include: the DOD **Unexploded Ordnance Center of Excellence, the DOD National Defense** Center for Energy and the Environment, the DOD Voluntary Protection **Program Center of Excellence, and the DOD Formerly Used Defense Site** (FUDS) Cleanup Program. Also, he served as the Army's Federal Preservation Officer and the Functional Representative for Career Program 12 (CP-12), Safety and the Interstate Technology and Regulatory Council. **Responsibilities spanned a global organization that included over a \$1.5** billion annual environmental program and oversight for the safety and occupational health of over 1.2 million Soldiers and Army Civilian employees worldwide. The DASA-ESOH worked with key personnel in the Army, the

Department of Defense, and other Federal and state agencies in developing and advocating Army policies for sustainability, environment, natural resources, safety, and occupational health programs in accordance with Presidential Executive orders, public laws, state and local standards, Department of Defense directives and the Army mission. The DASA-ESOH served under the general direction of the Assistant Secretary of the Army (Installations and Environment) and received broad strategic guidance from the Secretary of the Army. Oversaw a workforce of 50 combined military and civilians; directly supervises personnel at the SES/COL/GS-15 levels. Additionally, Mr. Wolfe served as Adjunct Faculty at the U.S. Army Management Staff College.
